## **MAKING A PURCHASE**

We have included this term to protect us in case we are no longer able to supply a particular product for some reason or a mistake has been made in pricing. If the goods you have ordered are not available we will inform you as soon as possible by phone or email.

We accept credit card payment via PayPal. If you are purchasing from a non-EU country your credit card company will convert the amount to your local currency.

## **BACK ORDERS**

If your item is not in stock, we will back the order for you. You will be e-mailed with the option to cancel your order if you prefer not to wait.

## **DELIVERY SCHEDULE**

We aim to dispatch and deliver orders within 24 hours, but please allow up to 5 business days. Orders are shipped using TNT Post Basic with a Track & Trace code. International orders are generally received in less than 8 business days. While every effort is made to deliver within the specified period, we shall not be liable to any person for loss or damage which may arise from not receiving the order on time.

## **TAX CHARGES**

For orders made within the Netherlands or the European Union, 21% VAT is added. All other orders are VAT- free.

## **GUARANTEE**

We guarantee your satisfaction. All of our products come with a 14 days no quibble guarantee.

## **RETURNS POLICY**

OASI GIFT SHOP will refund or exchange any merchandise which is returned in perfect condition and in original packaging within 14 days from the date of purchase.
